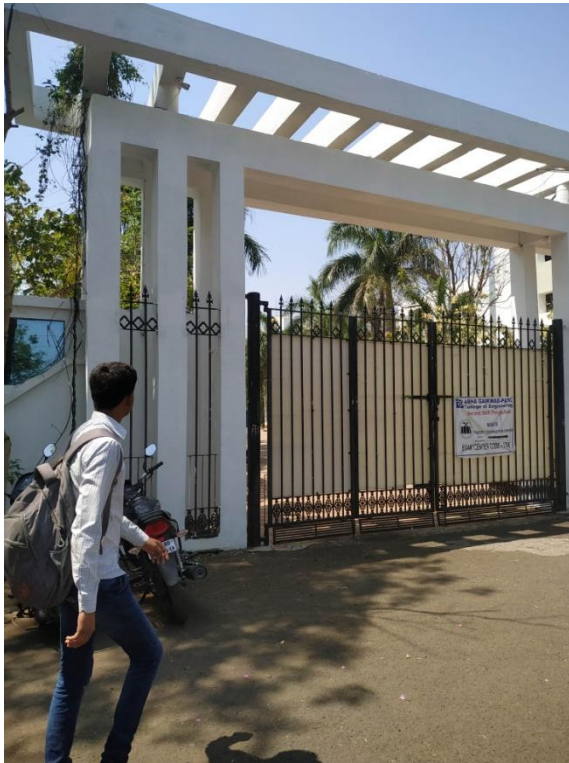
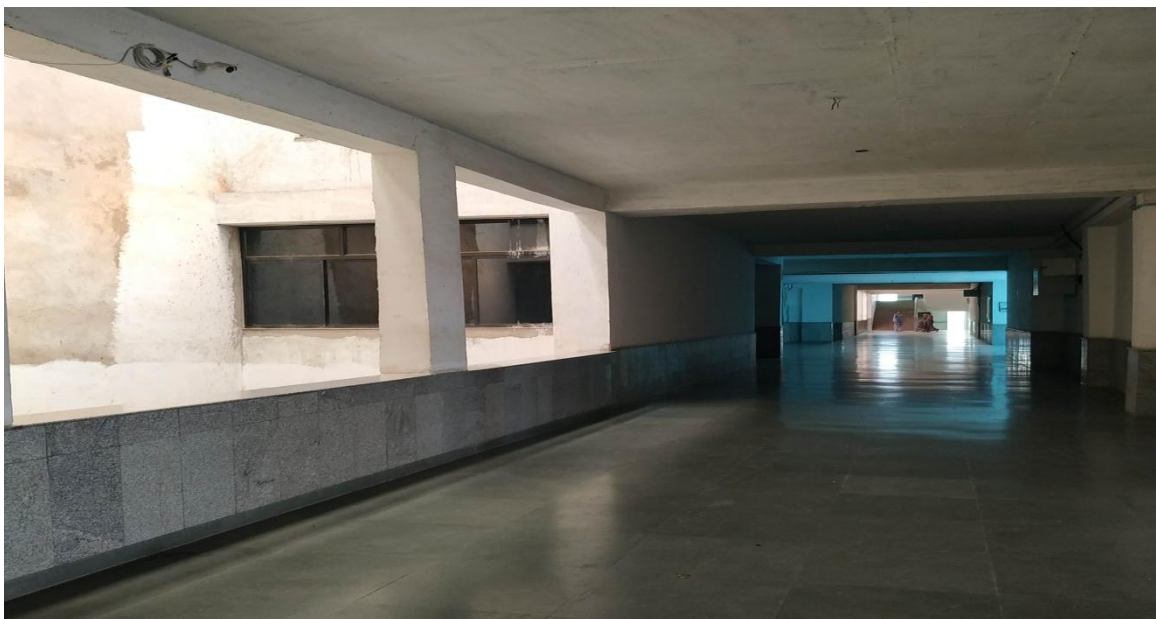


This is to inform it is mandatory for every to form the **Women Grievances Redressal Committee** for emphasizing the fact of women's right.
